



In the event that the English Language Requirements are not met, student may be required to undertake additional English module(s) prior to or concurrently with the undergraduate programme, based on the University's decision.

Prior entry into the **BA (Hons) Accounting, BA (Hons)** and **BComm (Hons) in Accounting and Finance**, applicants are required to obtain a minimum Band 2 in MUET or IELTS Band 5.5 or TOEFL 550.

Students holding equivalent academic qualifications that are not conducted in English, are required to sit for the English Placement Test, which may result in the undertaking of the English Enrichment Programme (1 to 10 months). Students who intend to commence the undergraduate programmes directly, are advised to fulfil the above English requirements prior reporting to the University.
