## **Important Information**

Student Name

- Documents MUST be submitted to the Faculty/Centre/Institute between 3 to 4 months before the expiration date of the Student Pass.
- However, if it comes for Coop it **CAN** submitted to the Faculty/Centre/Institute earlier than 4 months before the expiration date of the Student Pass with Coop Letter.
- Minimum requirement for Student Pass renewal are; CGPA 2.00 & above, attendance 80% & above, fulfilled English requirement, not
  exceeds studies duration AND any ad-hoc or additional requirement(s) by EMGS/ Immigration Department.
- The immigration department has the right to issue a FINAL student pass (no more extension) if exceeded studies duration.
