

Announcement From The International Office To All International Students Following Nationwide MCO From 12 May To 7 June 2021

Updated 25 May 2021

- The whole of Malaysia will be placed under the Movement Control Order (MCO) from 12 May 2021 to 7 June 2021.
- Interdistrict and interstate travel are not allowed except for work and economic purposes, health matters, emergencies, and vaccination appointments. Students who must travel interdistrict or interstate to campus are required to obtain a letter from the Student Affairs & Alumni via email at SAAEnquiries@ucsiuniversity.edu.my. Students who need to travel to the airport must obtain a permit from the nearest police station.
- The submission of the student pass application and collection of passport, *i*-KAD and medical cards will operate as usual during this period or until further notice. Students are advised to call the Visa Processing Unit (VPU) office at +60 3-9101 8880 before visiting campus.
- The VPU office will be closed on 26 May and 7 June 2021 in conjunction with the public holidays.
- Students are reminded to be vigilant, take precautions, and adhere to the MCO standard operating procedures (SOPs) and any changes announced from time to time. When leaving home, students are reminded to carry their passports, *i*-KAD, and medical cards at all times.

Announcement From The International Office To All To International Students Travelling To Malaysia

Updated 24 May 2021

Entry Restrictions for Students Arriving from United Kingdom, India, Bangladesh, Pakistan, Nepal and Sri Lanka

- International students embarking on a journey from United Kingdom, India, Bangladesh, Pakistan, Nepal and Sri Lanka are prohibited from entering Malaysia.

Update on Quarantine Period

- The Government of Malaysia requires all travellers including international students arriving from certain countries to undergo 14 days of quarantine upon their arrival in Malaysia.
- All travellers arriving from countries in the following link are required to undergo 14 days of quarantine upon their arrival in Malaysia:

Travel Requirement for New, Progression, and Programme Transfer Students

This information applies to international students who recently obtained a Visa Approval Letter (eVAL).

- Once the eVAL is approved by the Immigration Department of Malaysia, a Travel Authorisation letter will be issued along with it. Download these documents from the following link:

- **Students travelling from Single Entry Visa (SEV) required countries must apply for the SEV prior to travelling to Malaysia at the Malaysian Mission office.** The list of SEV required countries is available at the following link:

- Once your departure date is confirmed, inform the University by submitting the Airport Pickup form at the following link. Note that airport pickup services are not available until further notice, but the information submitted will be used to notify the University on your arrival to Malaysia.

- Undergo the RT-PCR Covid-19 Test three (3) days before travelling to Malaysia.

Travel Requirement for Current Returning Students

This information applies to international students who hold a valid Student Pass or are in the progress of renewing their Student Pass.

- Submit the Travel Authorisation application in the link below. Students are not required to book a flight ticket before the letter is issued.
