POST-DOCTORAL RESEARCH FELLOWSHIP SCHEME

1.0 Background

The appointment of Post-Doctoral Research Fellows provides faculties and institutes in UCSI

University with the opportunity to enhance their R&D activities and increase their research output,

in line with the vision of UCSI University to become one of the Research Universities in Malaysia.

2.0 Objectives

(i) To encourage the development of human capital in research in the university.

(ii) To increase the quantity and quality of research deliverables of the university.

3.0 Guidelines for Appointment of Post-Doctoral Research Fellows

3.1 Eligibility

Candidates must have a doctoral degree obtained from an institution of higher learning that is

recognized by the UCSI University Senate that was obtained within three (3) years from the date

of application.

3.2 Required Work Experience

The candidate has sufficient experience in carrying out research and is able to work independently

and has authored a minimum of four (4) publications in Web of Science (WoS) indexed journals

and minimum Scopus h-index of 3.

3.3 English Language Requirement

Candidate whose doctoral thesis was **NOT** written in English or graduated from institutions which

do not use English as a medium of instruction must fulfill the English language requirement of

minimum band of 6.0 in IELTS or its equivalent.

3.4 Age Limit

There is no age limit to the Post-Doctoral Research Fellow but is subject to being certified to be

fit to work by a medical doctor.

3.5 Research Area(s)

The Post-Doctoral Research Fellow must work in research area(s) that is(are) similar to or

compatible with the research area(s) of the supervisor and/or the faculty or institute that he/she is

affiliated to.

3.6 Tasks and Responsibilities

The Post-Doctoral Research Fellow is required to

(i) Conduct research on a full-time basis at the faculty/institute that the Post-Doctoral

Research Fellow is affiliated to:

(ii) Produce a minimum of five (5) publications (full length research articles or review

articles) in high impact WoS indexed journals (Q1 or Q2) per year as first or

corresponding author;

(iii) Supervise final year student projects and co-supervise postgraduate student projects

as assigned by the supervisor(s) and/or faculty/institute;

(iv) Handle tutorials and/or lectures for no more than four and a half (4.5) hours per

week;

(v) Submit a progress report to the supervisor and Office of Postgraduate Studies (OPS)

at the end of each month;

(vi) Submit a comprehensive final report to the supervisor and OPS at the end of the

(vii) Complete other tasks, duties and responsibilities as determined by the

faculty/institute and/or OPS.

3.7 Source of Funding

The salary/remuneration of the Post-Doctoral Research Fellow can be supported by either type of

the funding as described below:

(i) External funding:

• The organization or party that is sponsoring the Post-Doctoral Research Fellow's

appointment.

Or

• The funds from any external research grants or consultancy projects that have been

obtained by the Post-Doctoral Research Fellow's supervisor(s).

(ii) Internal funding:

• Faculty's budget and/or Office of Postgraduate Studies (OPS) and/or Centre of

Excellence in Research, Value Innovation and Entrepreneurship (CERVIE).

3.8 Approval of Appointment

All proposed appointments for the position of Post-Doctoral Research Fellows are subject to the

evaluation by the Evaluation Committee, which consists of the DVC for Research and

Postgraduate Studies (Chair), Director of OPS, Director of CERVIE, Dean/Director of the hiring

faculty/institute and the supervisor(s) of the Post-Doctoral Research Fellow from UCSI University.

The decision of the committee will be presented by the DVC for Research and Postgraduate

Studies (or a representative) in the Top Management Meeting (TMM) for noting, followed by

endorsement by University Council (UC).

3.9 Eligibility of Supervisor for Appointment

Academic staff with a research grant or multiple research grants as principal investigator (PI); or

a combination of multiple research grants as principal investigator (PI) and one (1) research grant

as co-investigator, worth at least RM 80,000.00 (Ringgit Malaysia Eighty Thousand only) is

eligible to request for a Post-Doctoral Research Fellow.

The appointment period of each Post-Doctoral Research Fellow is for a maximum of three (3)

years. At the end of each year of appointment, the performance of the Post-Doctoral Research

Fellow will be reviewed by an Evaluation Committee consisting of the DVC for Research and

Postgraduate Studies, Director of OPS and Director of CERVIE (Optional: the supervisor of the

Post-Doctoral Research Fellow) of UCSI University (Note: A Progress Report and a Contract

Renewal Evaluation Form will be submitted to the Evaluation Panel). If the performance of the

Post-Doctoral Research Fellow is found to be satisfactory and with the recommendation by the

Faculty Dean (where the Post-Doctoral Research Fellow is affiliated to), the appointment will be

continued until the completion of the appointment duration. If the performance of the Post-

Doctoral Research Fellow is found to be unsatisfactory by the Evaluation Committee, the

appointment will be terminated.

3.11 Type of Appointment

Contractual with appointment period of one (1) year for a maximum of three (3) years, subject to

annual performance evaluation as stated in 3.10.

3.12 Termination of Appointment

The appointment can be terminated by either party, by giving a three (3)-month notice in writing

to the other party.

3.13 Salary/Remuneration

The appointment of the Post-Doctoral Research Fellow will be paid a gross monthly rate as below:

First year	Ringgit Malaysia Five Thousand (RM 5,000.00) per month
Second year*	Ringgit Malaysia Five Thousand Five Hundred (RM 5,500.00) per month
Third year*	Ringgit Malaysia Six Thousand (RM 6,000.00) per month

(*The appointment continuation to second year and third year of the Post-Doctoral Research

Fellow is subject to annual performance evaluation as stated in 3.10)

Post-Doctoral Research Fellow (Malaysian) under the appointment of this scheme is eligible for

EPF, SOCSO and EIS contributions, insurance coverage and medical benefits/coverage as per the

University Employment Policy. Such contributions and benefits afore mentioned for foreign Post-

Doctoral Research Fellows will be determined according to the University Employment Policy, as

well as the latest government rules and regulations. Foreign Postdoctoral Research Fellows are

eligible for "Expatriates Housing Allowance entitlement" as stipulated in the Employee Handbook

of UCSI Group.

3.14 Leave Entitlement

Post-Doctoral Research Fellow under the appointment of this scheme is granted a leave entitlement

of sixteen (16) days per year which will be pro-rated. All leave applications must be made through

the IIS at least seven (7) days in-advance and approved by the supervisor.

3.15 Ownership of Intellectual Property (IP), Publications and Acknowledgement to UCSI

University

UCSI University claims ownership, unless agreed otherwise, of all IP arising from work developed

in the course of research or other activities undertaken by the Post-Doctoral Research Fellow

during the tenure of appointment either sponsored by UCSI University or an external body, subject

to any agreement with that external body.

All publications and deliverables produced by the Post-Doctoral Research Fellow based on the

research conducted during the tenure of appointment must be affiliated to UCSI University. Post-

Doctoral Research Fellow under this appointment scheme must acknowledge the financial

assistance from UCSI University in the "Acknowledgements" section of all publications produced,

submitted and/or published by the Post-Doctoral Research Fellow based on the research conducted

during the tenure of appointment.

3.16 Bench Fee

Post-Doctoral Research Fellow is waived from paying bench fee.

3.17 Visa, Visitor's Pass (Professional) and Personal/Security Bond

The appointment of the Post-Doctoral Research Fellow is subject to the Malaysian Immigration authorities issuing the successful applicant with a valid Visa. The Post-Doctoral Research Fellow attachment and continued attachment with the University shall be only for the duration of the validity of the Visa. The University shall submit the application for the Visa to the Immigration authorities on behalf of the respective Post-Doctoral Research Fellow.
